Subject:- Calculation of reserve price for institutional sites under development authorities.

Authority in its 49<sup>th</sup> meeting held on 28.05.2013 vide agenda item no. 49.21 and subsequent amendment in the 54<sup>th</sup> Meeting held on 09-11-2016 vide agenda item no 54.08 had approved the policy for fixation of prices of institutional sites on the basis of prices of residential plots.

2. Subsequently, PDA Patiala has proposed changes in the fixation of reserve price for sites mentioned at 1 (b & c),3(a), 4(c), 5 (d & e) and 8. Accordingly the Proposal of revised rate has been prepared and placed at Annexure-1.
3. The matter was placed before the Finance and Accounts Committee in 81<sup>st</sup> meeting held on 10.08.2017 vide agenda item no 81.01 and the same was approved with the remarks that all those sites which are to be sold through allotment may also be put to auction, if required.
4. The matter is now placed before the Authority for ratification of the decision taken by Finance and Accounts Committee vide Agenda Item no. 81.01

- Note:-
- Prevailing highest residential reserve price means the rate at which plots/sites sold in the last auction or reserve price for the last auction of that area/sector/scheme with 5% escalation for every year since the last auction.
  - The Rates for allotment of land for Educational, Health, Service Department and Office Building will increase proportionately if higher FAR than mentioned against these is allowed.
  - For sites to be allotted on 'Free of Cost' basis or below 'Collector Rate', the 'Income Tax' liability of Authority, if any, shall be recovered from the allottee.
