
Ref:- Incontinuation to this office letter No.PUDA-TPW-99/8213- 20 dated 24.9.98.

As per the decisions of the 11th meeting of the Planning & Design Committee held on 28.10.97 ^{policy} regarding Permitting Professional Consultancy Services in Residential Houses Constructed in Urban Estates and built up houses allotted by the Housing Board/PUDA was approved. The same was sent to your office vide letter dated 24.9.98 referred above. The policy was made applicable in first instance at SAS Nagar & Ludhiana only.

The issue was discussed again in the 13th meeting of the P & D Committee held on 5.5.99, it was decided to enlarge the scope of the policy as under:-

- i) The policy shall be made applicable to all the urban estates in Punjab as per detailed instructions already issued vide letter dt.24.9.98.
- ii) However the fees for allowing professional consultancy in other urban estates shall be linked with the land cost applicable in that urban estates. An agenda item shall be put up in the next F & A Committee for approval.

The policy is now applicable in all urban estates of Punjab, however, the fees to be charged for allowing the professional consultancy for urban estates & other than SAS Nagar & Ludhiana will be conveyed to you separately after its approval by F & A Committee.


