This notification is made under the provisions of Section-11of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013. As per provision of the Section 40(4) of the Act *ibid*, all of the provisions of Chapter-II to Chapter VI shall not apply. District Revenue Officer, SAS Nagar has been hereby notified as Administrator (Rehabilitation and Resettlement).

In exercise of the powers conferred by the aforesaid section, the Governor of Punjab is pleased to authorize the officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey the land in the said locality and do all other acts required or permitted by Section 12 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act, 2013.

Further, in exercise of the powers under the said Act, the Governor of Punjab is pleased to direct that action under section 40(2) & 40(4) shall be taken in this case on the grounds of urgency and importance of the public purpose and the provisions of Section 15(1) of the said Act shall not apply with regard to this acquisition.
