No. 6/30/2010-6HG1/1138317/1, Whereas the State Government had acquired land of Village Deri, Dhurali, Manakpur Kalar, Bakarpur, Matran, Seon, Chachu Majra, Rurka, Nogiari, Chau Majra, Manauli comprised in Khasra numbers specified in notification no. 6/30/2010-6HG1/3946 dated 22.12.2010 issued under section 4 and State Government issued notification under section 6 of the Land Acquisition Act, 1894 vide notification no. 6/30/2010-6HG1/3480 dated 25-08-2011 for the public purpose of setting up of I.T. City/ Knowledge Park of SAS Nagar.

Land owner Sh. Prithi Chand S/o Sh. Kesar Singh resident of village Bakarpur, Tehsil S.A.S. Nagar has brought to notice that his land measuring 0-19 Marla falls in khasra number 240 has been acquired which otherwise falls at a distance far from the acquired boundary. The matter has been deliberated at the level of DTP and it has been conveyed vide their letter no. 1560 dated 27.2.2013 that the distance of this land is approximately 600 mtrs. from the acquired boundary hence this land is not to be acquired for the above said scheme.

Now, said Act of 1894 has since been repealed by the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and further action is to be taken under this new Act.

Therefore, in exercise of the powers conferred under Section 93 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 is pleased to withdraw from the land acquisition proceeding initiated vide notification no. 6/30/2010/6HG1/3946 dated 22.12.2010 issued Under Section 4 and notification no. 6/30/2010/6HG1/3480 dated 25.08.2011 issued under Section 6 of Land Acquisition Act, 1894 for acquisition of land measuring 1693.8124 acres for the purpose of I.T. City/ Knowledge Park, District S.A.S. Nagar, the following land:
