Whereas, the Governor of the Punjab is satisfied that land is needed by the Government, at the public expense for public purpose, namely for Acquisition of remaining khasra numbers of land for construction of 100 feet wide road connecting Sector 79/80, 85/86 Junction to Landran Banur Road in accordance with the duly notified Master Plan of S.A.S. Nagar issued vide Drawing No. 1991/2008 DTP(S) dated 19.11.2008 in the area of Tehsil & District SAS Nagar. It is hereby declared that the land described in the specification below is needed for the above purpose.

This declaration is made under the provision of Section -6 of the Land Acquisition Act, 1894, to whom it may concern and under the provision of Section 7 of the said Act. The Land Acquisition Collector, Urban Development Department, S.A.S Nagar, is hereby directed to take orders for the acquisition of the said land.

Plans of the land may be inspected in the office of the Land Acquisition Collector, Urban Development, Punjab, PUDA Bhawan, Ground Floor, Sector 62, S.A.S Nagar.

In the view of the urgent importance of the public purpose, the Governor of Punjab in exercise of the powers under Section-17(2)(4) of the said Act, is further pleased to direct that the land Acquisition Collector, Urban Development, Punjab, SAS Nagar, shall proceed to take possession of the land thereafter specified in accordance therewith.
