No. 6/30/2011-6HGI/2655.—Whereas it appears to the Governor of Punjab that land is likely to be required to be taken by the Government at the expenses of Punjab IAS, PCS Officers Co-operative House Building Society Ltd., S.A.S. Nagar for public purpose, for setting-up a residential colony at Mullanpur in the area of tehsil Kharar, district S.A.S. Nagar. It is hereby notified that the land in the locality described below is likely to be required for the above purpose.

This notification is made under the provisions of Section 4 of the Land Acquisition Act, 1894, to whom it may concern.

In exercise of the powers conferred by Section-4 of the aforesaid Act, the Governor of Punjab is pleased to authorize the Land Acquisition Collector, Urban Development, Punjab, S.A.S. Nagar, for the time being engaged in the undertaking with their servants and workmen to enter upon and survey the land described in the specification given below and do all other acts required or permitted by that section.

Any person interested, who has any objection to the acquisition of said land mentioned below in the specification, may within thirty days of the publication of this notification in the Official Gazette, file any objections or suggestions in writing before the Land Acquisition Collector, Urban Development, Punjab, PUDA, Bhawan, Sector 62, S.A.S. Nagar.
