NOTIFICATION

No.6/56/2013-6HG1/333029/1 Whereas land acquisition proceedings in respect of land specified below were initiated, before coming into force on 01.01.2014 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013), by publishing a preliminary notification, No. 6/56/13/6Hg1/110229/1 dated 15.10.2013 in the Punjab Government Gazette dated 15.10.2013 in the two daily newspapers i.e. "Jagbani" & "Daily Post" dated 24.10.2013 and Public Notice published in the locality as per rapat no. 104 dated 05.11.2013 of the Roznamcha Waqiyati of the concerned Patwar Circle, under section 4 of the Land Acquisition Act, 1894.

Whereas Governor of Punjab is satisfied that land specified below is needed by the Government at the Public expenses for public purpose, namely for **Acquisition of land for construction of 40 mtr. wide road dividing Sectors 101/102, 101/103, 101/102A** in accordance with the duly notified Master Plan of SAS Nagar issued vide Drawing No. 1991/2008 DTP(S) dated 19.11.2008 in the area of Tehsil & District SAS Nagar and it is hereby declared that the land described in the specification below is required for the above public purpose.

This declaration is made under the provisions of Section 6 of the Land Acquisition Act 1894 to be read with Sub-Section 1 of Section 24 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013), to all whom it may concern and under the provisions of Section 7 of Land Acquisition Act 1894, the Land Acquisition Collector, Urban Development, Ground Floor, PUDA Bhawan, Sector-62, SAS Nagar is hereby directed to take order for the acquisition of the said land.

Determination of compensation in respect of said land shall be made as per the provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013.

Plan of the land may be inspected in the offices of the Collector of SAS Nagar district and of the Land Acquisition Collector, Urban Development, Ground Floor, PUDA Bhawan, Sector-62, SAS Nagar
