**No 6/43/2013-6HG1/385882/1** Whereas the land acquisition proceedings were initiated vide notification no. 6/43/2013/6HG1/2884 dated 10.09.2013 issued under Section 6 of the Land Acquisition Act, 1894 (since repealed) for acquisition of land measuring 11.9119 Acre of Village Hoshiarpur 7.375, Mullanpur Garibdas 2.5312, Parol 0.225, Ferozpur Bangar 0.9562, Majra 0.4875 and Sultanpur 0.337 (Total Area 11.9119 Acre) for the public purpose namely Construction/Upgradation of road from Punjab/UT border (near Mullanpur) to Siswan T-Junction in Local planning Area, and Town Planning and Development Board.

Whereas the possession of the land comprised in the above said notification, was taken vide by making 80% compensation and now the Government of Punjab has decided to denotify the above said notification issued under section 6 of the Land Acquisition Act, 1894 as the area belongs to Central Government (In the name of Defence).

Whereas the said Act of 1894 has since been repealed by the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and further action is to be taken under this new Act.

Now, therefore, in exercise of powers conferred under Section 93(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the Governor of Punjab is pleased to withdraw the land acquisition proceedings initiated vide notification no. 6/43/2013/6HG1/2884 dated 10.09.2013 issued under section 6 of the Land Acquisition Act, 1894 for acquisition of land measuring 0 Bigha 9 Biswa out of 11.9119 acres for the public purpose of namely Construction/upgradation of road

from Punjab/UT border (near Mullanpur) to Siswan T-Junction in Local planning Area, and Town Planning and Development Board.
