Vide letters referred to above policy regarding permitting Professional Consultancy Services in Residential Houses constructed in Urban Estates & built up houses allotted by Housing Board/PUDA was communicated. The policy now covers all Urban Estates of Punjab. The issue of fixing of charges for permitting Professional Consultancy Services in the houses etc. was considered by Finance & Accounts Committee in its 22nd meeting held on 2.2.2000 under Agenda Item No.22.06. The Committee has approved the following charges for permitting such services for different Urban Estates as under:-
